#### **ELECTION PROGRAMME 2024-26**

This is to notify to all the members that Biennial General Elections of the Executive Committee and Office Bearers of Pakistan Textile Exporters Association will be held under The Trade Organizations Act, 2013, The Trade Organizations Rules, 2013 and Memorandum & Articles of Association.

- 01. Elections would be held for the vacant seats of 24 members of Executive Committee retiring on 30.09.2024, after completing their tenure.
- 02. As per Trade Organizations Act No.II, of 2013, clause 2(k), elections would be held for office of Chairman, Senior Vice Chairman and Vice Chairman amongst the Executive Committee Members.
- 03. Election Schedule for elections of Executive Committee Members and Office Bearers is attached.
- 04. As per Trade Organizations Amendment Act, 2022(of 2022), tenure of Office Bearers for 2024-26 will be two years starting from Ist October, 2024 to 30<sup>th</sup> September, 2026 and tenure of members of executive committee elected in biennial elections 2024-26 will be two(2) years starting from Ist October, 2024.
- 05. As per Trade Organizations Rules, 2013 clause 15, only such Companies/Firms/Proprietary concerns:
  - i) who have been enrolled as Members of the Association and have completed 2 years of valid membership of Association as on or before 15.07.2024, will be eligible to vote for elections 2024-26.
  - ii) and have paid their current subscriptions/renewal fee and other dues and have furnished proof of filing of annual return of income tax under Income Tax Ordinance 2001 or Assessment Order for preceding assessment year in the name of firm/proprietary concern/company.
  - iii) and have deposited their Identity Cards or have notified any change of representative by 19.07.2024, shall be entitled to cast vote or stand for elections or nominate a candidate for elections.

- iv) Only one person who is Director/Partner or Proprietor of a Firm/Company which is valid member of the Association shall be eligible to <u>contest</u> from his Firm.
- ONLY Proprietor, Partner of a Firm or Director of the Company concerned or GM (in case of multi-national Company) shall be entitled to <u>cast</u> his vote at the time of Biennial Elections if he has already been nominated for voting and registered as such with the Secretary General and his name appears on the final list of voters. In case any person is Director or Proprietor/Partner of more than one Firms/Companies, he shall be entitled to cast only ONE vote and not of other sister concerns.
- 07. All members should ensure that their Identity Cards complete in all respects are available in the office of the Association. Those members who have not yet submitted Identity Cards may do so by 19.07.2024. Identity Card Forms can be obtained from the PTEA Office on any working day. Identity Card Form is also enclosed with Election Programme.
- 08. No Vote by proxy will be cast during the Biennial Elections 2024-26.
- 09. Polling will be held in the office of the Association located at 30/7 Civil Lines behind State Bank, Faisalabad from 9 A.M. to 5 P.M as under:
  - i) for Executive Committee on 04.09.2024, Wednesday.
  - ii) for Office Bearers on <u>09.09.2024</u>, <u>Monday</u>. (Chairman, Senior Vice Chairman & Vice Chairman)
- 10. Any candidate or his agent wishing to be present at the time of scrutiny of nomination papers will be free to do so after prior notice in writing to the Secretary General a day earlier.
- 11. The candidates can appoint one Polling Agent each and will inform the Election Commission in writing on their letter head accordingly.
- 12. Each candidate will provide one copy of his National Identity Card and 5xpassport size photographs at the time of filing of nomination papers in PTEA Office on 20.08.2024 which is the last date for filing of nomination papers.
- 13. For all election purposes Office Hours will be from 9 A.M. to 5 P.M.
